

## SCHOLARSHIP INFORMATION

The W. Phil Wynn Memorial Scholarship is limited to students enrolled in a four-year program. Each applicant must:

- Be a member of Virginia Educators Credit Union (VECU) who has not previously been awarded a scholarship from VECU.
- Be a graduating high school senior.
- Have a cumulative grade point average (GPA) of 3.0 or higher.
- Submit a one-to-two page, typed, double-spaced essay with a font size of 12.
- Submit a sealed copy of your most recent high school transcript.

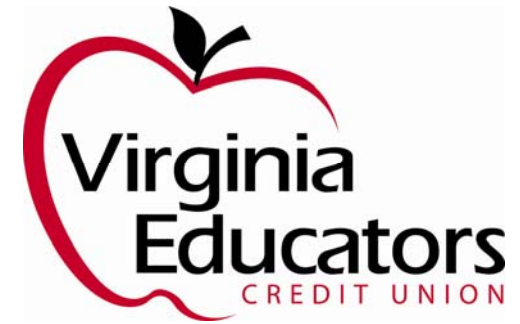

The \$1,500 scholarship is paid directly to the winner's college or university. Once registered, please forward enrollment verification from your school to Virginia Educators Credit Union (VECU).
